**Indoor Air Rifle Competition (Morning):**

**Must be present by 10:00 AM to compete**

- ⊙ To be eligible to take part in this tournament you **MUST** be registered as a 4-H Shooting Sports Air Pellet Rifle project member as recognized in your county.
- ⊙ Only .177 Pellet Air Rifle is allowed. Iron Sights **ONLY** allowed – NO telescopic.
- ⊙ Wisconsin State Air Pellet Rifle Rules will be followed\*
- ⊙ Competitors must supply their own .177 Pellet Air Rifle and pellets.
- ⊙ Divisions will be as follows:

Unlimited Sporter***

Division 1 (8 yr. – 11 yr.) Junior  
Division 2 (12 yr. – 14 yr.) Intermediate  
Division 3 (15 yr. – 19 yr.) Senior

**Indoor .22 Rifle Competition (Afternoon):**

**Must be present by 1:00 PM to compete**

- ⊙ To be eligible to take part in this tournament you **MUST** be registered as a 4-H Shooting Sports .22 Rifle project member as recognized in your county.
- ⊙ Only .22 Rifle is allowed. Iron Sights **ONLY** allowed – NO telescopic.
- ⊙ Wisconsin State .22 Rifle Rules will be followed\*
- ⊙ Competitors must supply their own .22 Rifle and ammunition.
- ⊙ Divisions will be as follows:

Target***

Division 1 (12 yr. – 14 yr.) Intermediate  
Division 2 (15 yr. – 19 yr.) Senior

**Wildlife Ecology Competition:**

- ⊙ To be eligible to take part in this tournament you **MUST** be registered as a 4-H Shooting Sports project member as recognized in your county.
- ⊙ NOTE: Competition will be open at 9:00 AM. (No Fee)  
All competitors must be finished BY 12:00 NOON
- ⊙ At 12:30 PM, answer ID cards will be displayed for viewing.
- ⊙ Divisions will be as follows:

Division 1 (8 yr. – 11 yr.) Junior  
Division 2 (12 yr. – 14 yr.) Intermediate  
Division 3 (15 yr. – 19 yr.) Senior

- ⊙ Each shooter will fire from 3 positions: prone, standing, and kneeling. Shooter must be in the proper position while shooting. 10 shots at each target for a total of 30 shots.  
Pellet Air Rifle at 10 meters (33 feet) .22 Rifle at 50 ft.
- ⊙ Time limit is 10 minutes per position. 5-minute Sight-In – Prone Position only. .
- ⊙ Targets: Pellet Air Rifle - standard NRA Ar-5/10.  
.22 Rifle - standard NRA A17
- ⊙ Rifles must be loaded and fired in a single fashion only.
- ⊙ Iron Sights ONLY – NO telescopic
- ⊙ Competitors must stand alone at the line of competition. No coach, leader, spotter, or other person may accompany or assist the competitor except as approved by the range officer in charge of the event.
- ⊙ Wisconsin State Air Pellet Rifle Rules will be followed for Air Rifle competition.  
Wisconsin State .22 Rifle Rules will be followed for .22 Rifle competitions.
